Privacy Policy

HOPE SPRING ETERNAL INTRODUCTION AGENCY (“us”, “we”, or “our”) operates the <http://www.hseia.com> website (the “Service”). Definitions

Types of Data Collected

Service

Service is the <http://www.hseia.com> website operated by HOPE SPRING ETERNAL INTRODUCTION AGENCY

Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

Usage Data

Usage Data is data collected automatically either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

Cookies

Cookies are small pieces of data stored on your device (computer or mobile device).

Data Controller

Data Controller means the natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any personal information is, or is to be, processed. Information Collection And Use

We collect several different types of information for various purposes to provide and improve our Service to you.

Types of Data Collected

Personal Data

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

- Email address
- First name and last name

- Phone number
- Address, State, Province, ZIP/Postal code, City
- Cookies and Usage Data

Usage Data

Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyze our Service. - Security Cookies. We use Security Cookies for security purposes.

Use of Data
